



We are located within the Department of Global Health. We use multipronged strategies to increase uptake of evidence into policy and practice to impact the sustainable development goals, especially Goal 3.

- The work of our team has had demonstrable impact on important public health interventions.

There is increasing interest to ensure that health policymaking and practices are informed by research evidence to improve the performance of health systems and the attainment of the Sustainable Development Goals (SDGs).

Translating research into policy starts by doing research on the right questions and it requires up-to-date, independent, rigorous systematic reviews. We engage with decision makers at national level and with the World Health Organisation (WHO), contribute to guideline development and we focus on conducting reviews on relevant topics. We have demonstrated through our collaborative projects how these timely, well conducted systematic reviews influence policies. Rigorous systematic reviews have a clear bottom line, include an assessment of the certainty of the evidence, and highlight research gaps.

TARYN YOUNG DELIVERED HER **INAUGURAL LECTURE:**

"Influencing the evidence ecosystem – a reflection"

The evidence ecosystem represents the dynamic and complex interactions between evidence production, evidence synthesis and evidence translation within the broader complex healthcare context. This inaugural lecture shared experiences and reflected on initiatives implemented in the past two decades to influence the evidence ecosystem. Various factors impact on the flow of evidence from primary to secondary research to policy to implementation. A key element is the conduct of regionally relevant and robust research addressing priority health problems. Systematic reviews are well-recognised as good evidence sources and efficiencies of their use in policymaking have been argued extensively. To increase the uptake of research evidence in healthcare policy and practice, facilitators and interventions can target policymakers, researchers, exchanges between them, and their environment. Key to these are interpersonal

relationships and communication between research users and producers. Dedicated capacity development initiatives play a critical role to support both the conduct and use of research evidence – especially equipping the next generation of healthcare practitioners, healthcare managers, policy makers, and researchers to be critical thinkers and lifelong learners. Above all, working together, sharing best practices and lessons learnt, minimising unnecessary duplication and fostering equitable partnerships will help us to go further in our guest to advance health and healthcare in the African region. CONTRIBUTING TO THE FIRST **EVIDENCE-BASED FIRST-AID GUIDELINE** FOR FIRST RESPONDERS IN AFRICA

Members from the CEBHC contributed to the development of the first evidence-based first-aid guideline for first responders in Africa. First responders are laypeople who are trained in advanced first-aid and are the first line response within a community when acute care is needed. In developing this first-aid manual, a total of 87 evidence summaries were generated, including evidence from over 13 Cochrane Reviews. The manual is likely to be the most forward thinking first-aid manual globally, tackling important issues typically outside the mandate of traditional first-aid guidance documents and manuals. These include i) road traffic accident safety ii) common illnesses and diseases iii) transport and movement of the injured iv) dealing with the deceased and v) disaster readiness. Developed by the Belgian Red Cross Centre for Evidence-based Practice, the manual is scheduled to be launched in Malawi. South Africa and Zimbabwe in 2020.

EVIDENCE INFORMED GUIDELINE DEVELOPMENT AND IMPLEMENTATION

The African Federation for Emergency Medicine - together with the CEBHC – developed a clinical practice guideline (CPG) for South African prehospital providers, setting the standard of practice in emergency care in South Africa. However, there are still gaps and challenges around future guideline development and current implementation approaches. Research has been conducted to address these gaps, with a significant focus on translating this evidence to paramedics, industry regulators and decision makers. Led by Michael McCaul, as part of his PhD, various tailored target audience specific knowledge translation products were created, informing guideline implementation committees underlying evidence and national implementation strategies. These knowledge translation products, among others, included issue briefs for stakeholders, YouTube vlogs and national newsletters for clinicians and invited face-to-face presentations at national committee meetings.



COCHRANE SPECIAL COLLECTIONS **ON ACUTE MALNUTRITION**

Cochrane Nutrition, co-hosted by the CEBHC, produced these Collections on the prevention and treatment of acute malnutrition, which include relevant Cochrane Reviews published since 2013, to support decision-makers and health professionals in the implementation of evidenceinformed policies, programmes and practices for treating and preventing acute malnutrition. This was a collaborative initiative with Evidence Aid and other humanitarian sector stakeholders, including Médecins Sans Frontières, Save the Children, Action Against Hunger, Emergency Nutrition Network, Scaling Up Nutrition (SUN) Movement Secretariat, and World Food Programme.

ADVANCING METHODS IN EVIDENCE SYNTHESIS – GRADE SOUTH AFRICA **NETWORK**

A GRADE network serves as the primary hub within a region for GRADE-related questions and for support and collaboration opportunities. The South Africa GRADE Network (https://www.cebhc.co.za/research-what-we-do/southafrica-grade-network/) aims to advance the use of GRADE for evidence-informed decision-making for policy and practice in South Africa. Through the Network we aim to bring together contributors to GRADE within South Africa, jointly agree on the priorities and strategies for advancing GRADE activities, and build on the extensive research and training experience of individuals within the Network to coordinate and maximise GRADE training, research and guideline activities in South Africa. The Network is jointly managed, and led, by the CEBHC and Cochrane South Africa. The South African GRADE Network was formally launched at the African Cochrane Indaba held in Cape Town in March 2019.

Prevention and treatment of acute malnutrition in humanitarian emergencies: a multi-organisation collaboration to increase access to synthesised evidence

Enhance knowledge, skills and practices of key stakeholders in evidence-informed health care

During 2019, various activities were offered at undergraduate, postgraduate and continuing professional development level. Centre staff supervise and provide methodological mentorship and support to various postgraduates, including postdoctoral students.

Six postgraduate students supervised by Centre staff graduated, input to under- and post-graduate programmes continued and we implemented various workshops and seminars to advance EBHC knowledge and skills.

MSC CLINICAL EPIDEMIOLOGY

The MSc in Clinical Epidemiology (www.sun.ac.za/ clinepi) offers rigorous methodological training for health professionals who wish to pursue careers in clinical research and/or evidence-based health care practice. The academic leadership for this programme is provided by the Director of the CEBHC. Programme intake has grown exponentially over the past few years and we are attracting students from a wide geographic area. It is a part-time programme that runs over two years and offers a blend of face-to-face contact sessions, e-learning and self-study. It has employed various innovations, including a mentorship component and a system of teaching assistantship that provides support to both the students and convenors of the programme. In 2019 we reached 152 graduates. The MSc in Clinical Epidemiology programme is inseparable from the work of the CEBHC as staff play key roles in enhancing and expanding the programmatic offering - staff convene various modules, facilitate sessions, provide teaching assistance and support, and are involved in the development and implementation of new structured modules.

ADVANCING EVIDENCE INFORMED PUBLIC HEALTH

As part of capacity building activities within the Collaboration for Evidence-based Healthcare



and Public Health in Africa (CEBHA+), a 5-year project that aims to build long-term capacity and infrastructure for evidence-based healthcare and public health in sub-Saharan Africa, the CEBHA+ capacity development working group developed a 5-day, interactive, face-to-face workshop on evidence-based public health (EBPH). The workshop aims to introduce the concepts of EBPH and focuses on asking questions, and finding, appraising, interpreting and applying best evidence to public health questions relevant to the African setting. Anke Rohwer was part of a team of CEBHA+ facilitators from Rwanda, Malawi, Germany and South Africa, that offered the EBPH workshop in Kigali, Rwanda from 23-27 September 2019. Twenty-five participants, including public health practitioners, health care professionals and researchers attended the workshop. The workshop was well received and participants actively engaged in discussions and class exercises. They indicated that the content was relevant and applicable to their daily work.

DOING THE RIGHT THING: A WORKSHOP ON RESEARCH INTEGRITY AND PUBLICATION ETHICS

The annual conference of the Public Health Association of South Africa (PHASA) took place from 16-18 September 2019, at the Cape Town College. Anke Rohwer and Michael McCaul facilitated a 2-hour workshop on research integrity. The workshop aimed to introduce research integrity and its importance in health research and to promote good practice when reporting research. They presented various scenarios related to authorship, conflicts of interest and plagiarism and asked participants to assess whether the practices portrayed in the scenarios were acceptable or not by submitting an anonymous response through an online clicker system. Thereafter, they divided participants into small groups to discuss scenarios in more detail, including

reasons for engaging in poor practices and suggestions of how to do things differently. The workshop ended with a presentation on international best practices and guidelines linked to authorship, plagiarism and conflicts of interest, including where to find them and how they can be implemented.

BRIDGING THE GAP BETWEEN RESEARCH AND POLICY: ENHANCING KNOWLEDGE TRANSLATION CAPACITY

In order to advance the CEBHC's efforts to enhance capacity in knowledge translation, three workshops were offered in 2019 by Dr. Nasreen Jessani, The foundational workshop titled "The Art, Science and Complexity of Knowledge Translation: Introduction to Evidence Informed Decision Making" was offered to new students in November 2019. A follow up workshop on "Engaging with decision-makers: Issue Briefs for Policy and Practice" was offered twice: Once in April and once in November to participants who had already attended the foundational workshop. The Foundational workshop was attended by participants from government, academics, NGOs and advocacy organisations, Participants produced stakeholder maps and analyses for their particular policies, projects or issues. These were complemented by an engagement strategy for one priority stakeholder. The "Engaging with Decision-makers" workshops were attended by a similar variety of participants. Each left with a penultimate draft of an issue brief for a priority decisionmaker. These workshops also included Dr. Moodley – a VIP guest from the Western Cape Provincial Department of Health. Dr. Moodley engaged with participants on a variety

of topics, provided feedback on their final issue briefs and provided real world examples of the role of research (and researchers) in policy making. The issue briefs to date have served to contribute to decision-making on topics as varied as Emergency Medical Care, to Screen for Hypertension, and to Housing for the Homeless.

RENEWED MBCHB CURRICULUM

The CEBHC has since its inception led and contributed to research on how best to facilitate learning of EBHC. Over the past year we have been co-leading the planning of the integration of EBHC learning in the renewed MBChB curriculum, which will be implemented at the Faculty of Medicine and Health Sciences, Stellenbosch University in January 2022. Enabling and key EBHC competencies will be integrated as learning outcomes into all modules across the six study years, and with a dedicated module in the 4th and 5th study years to equip students with the knowledge and skills to identify and apply all the components of a research project, including reviewing the literature, phrasing clear questions, research methodology, and ethical considerations in research.

KEY CONCEPTS FOR INFORMED CHOICES

Celeste Naude and Anel Schoonees are contributing to this international project. Everyone makes claims about what works. However most people often fail to think critically about the trustworthiness of claims. This project presents a set of principles for assessing the trustworthiness of claims about what works, and for making informed choices ('Key Concepts for Informed Choices'). https://www.nature.com/ articles/d41586-019-02407-9

EVIDENCE BASED HEALTH CARE AND **COCHRANE REVIEWS**

Michael McCaul and Anel Schoonees presented a one-day workshop on evidence-based health care and Cochrane systematic reviews in Lusaka, Zambia on 26 November 2019. This workshop aimed to increase awareness about the need for EBHC, introduce knowledge and skills required to access, appraise and interpret evidence from Cochrane reviews, and briefly describe the role of Cochrane and Cochrane Africa. It consisted of didactic but interactive presentations, aided by

the software Mentimeter to gather live responses from the audience during presentations. More than 50 participants attended. They were university staff, postgraduate students and healthcare researchers in Zambia. Most participants had little to no previous experience with systematic reviews, with some (n=14) who had some previous dealings with the topic. Participants' feedback was positive, both during the workshop and from the formal online evaluation. Participants specifically appreciated the informative and interactive nature of the workshop and chose the searching and meta-analysis sessions as highlights. When asked what participants would do with the information gained, various students were motivated to pursue conducting a systematic review, including for doctoral studies, "improve my search for literature" and use the knowledge to "phrase research questions, use important databases and interpret meta-analysis results".

IMPROVING YOUR TRAINING SKILLS: A WORKSHOP FOR COCHRANE TRAINERS

Anke Rohwer and Prof Susan van Schalkwyk, director of the Centre for Health Professions Education (CHPE) at the FMHS, were commissioned by Cochrane to develop a train the trainer curriculum for Cochrane trainers and to facilitate a one-day workshop based on the curriculum at the annual Cochrane Colloquium in Santiago, Chile in October 2019. Although the Colloquium was cancelled last-minute due to civil unrests in Chile, we were still able to proceed with offering this pre-conference workshop for attendees who had already travelled to Santiago. The workshop aimed to
